A new letter will be submitted this month reminding them of the statute requirement. The County is effectively forcing the Library Board to go to court to force the judgement.

Joan Augustine motioned to employ Kavanagh Scully to pursue a second demand letter to the Putnam County Board, requesting the County honor their requirement to share the required percentage of the Personal Property tax with the Putnam County Library District. Sally Young second. Motion carried.

A letter was received from a Lostant couple objecting to our library "medium" program. It was one of our best attended programs and has a waiting list.
